ORDER

The schedule for Election of Himachal Pradesh State Bar Council was published on 16.02.2026. In terms of the said schedule provisional Electoral Roll was published on 4th March, 2026 and objections to provisional Electoral Roll could be filed/submitted on or before 11th March, 2026.

Total 341 objections/representations were received till 11.3.2026.

Out of above 341 objections/representations the objections/representations of 201 (Two Hundred One) Advocates have been allowed for the reason that all such Advocates have become eligible on account of having received their respective COPs (Certificate of Practice) from Bar Council of India within 5 years of the last date i.e. 14.11.2025 prescribed by H.P. State Bar Council for submission of Verification Form and requisite declaration in terms of certificate and place of practice (Verification) Rules, 2015. As per Rule 17 of 2015 Rules the verification process is required after every five years, therefore, those advocates who have received their respective COPs from Bar Council of India within the period of five years preceding the last date for submission of verification Forms are held entitled to be included in the final electoral rolls. A list of 201 Advocates whose names have been ordered to be included in final electoral rolls is annexed as **Annexure "A"**.


